Please note that year-over-year changes are calculated as the difference between values during the current period and the corresponding values during the same one year ago.

$$\text{Year-Over-Year Changes} = (\text{Amount during Current Period}) - (\text{Amount during Same Period one year before})$$

3. Definitions:

$$\text{Market Share in Value (\%)} = 100 * (\text{Value for a country}) / (\text{Total Value for US-All Countries})$$

4. Import Value is based on District of Entry data, not District of Unlading.
